# School Description and Mission Statement (School Year 2020-2021)

#### **About Our School**

Principal Fieberg has been an educator for 17 years serving as a classroom teacher, Teacher on Special Assignment in Instructional Services, Assistant Principal, and now Principal. She holds a BS in Elementary Education, a multiple subject credential, an MA in Reading Education, a reading specialist credential, as well as an administrative credential.

Sage Canyon School opened in September of 2000 to serve kindergarten through sixth-grade students. This year, we begin our twentieth year serving approximately 401 in-person students in 22 general education classrooms and one special day classroom. Sage Canyon also has 162 students in the Launch Distance Learning Program. This year, in alignment with our Safe Reopening Plan, kindergarten through third-grade classrooms maintain a student to teacher ratio of approximately 18:1, while fourth through sixth grade maintain a 21:1 ratio. Sage Canyon's student population represents six different ethnic groups and twelve different languages.

Through a commitment to social, emotional, and academic growth, as well as a safe, welcoming, and inclusive school environment, Sage Canyon maximizes the development of the whole child. Each individual's strengths are nurtured and valued as a contributing member of our community. Daily, students further develop critical thinking skills, curiosity, and communication skills. We are committed to providing an innovative, personalized, relevant educational program for all of our students. Our goal is for each child to realize his or her full potential. Yearly, we ensure teachers receive professional development in the area of Cognitively Guided Instruction in mathematics. Additionally, in collaboration with Harvard's Project Zero, staff focus on the cultural forces necessary to create a culture of thinking across Sage Canyon's classrooms. Our classroom environments are flexible and student-focused in an effort to promote student agency and ownership of the learning process. In addition, we want each child to develop strong self-esteem and good character. All Coyotes practice developing the Sage Success Skills including empathy, embracing diversity, grit, integrity, and self-control. We practice developing these skills through the use of the Second Step Curriculum.

Through our STEAM+ Program, we offer weekly classes taught by credentialed specialists in the area of art, physical education, science, and an integration specialist incorporating elements of design thinking in integrated lessons. We want learners to develop a passion for science, to become excellent at applying mathematical knowledge to solve problems, and to have a clear understanding of technology as an important tool in learning. We want our Coyotes to be physically fit, as well as have an appreciation for the fine arts.

We are particularly proud of our productive relationship with our dynamic and involved parental community. So many great aspects of our school rely on the continued support of our parents. There is no doubt that Sage Canyon is thriving because of parental commitment and involvement. A school is as strong as the partnerships between its community of parents, staff, and students. Sage Canyon is living proof of this!

# School Safety Plan (School Year 2020-2021)

Our school is a modern, state-of-the-art complex with a safe, clean environment that is conducive to productive learning. A comprehensive safety plan incorporates policies and procedures for injury and illness prevention for students and staff. Site safety representatives work with the district safety committee to practice, revise, and update the safety plan as needed. We conduct regular safety inspections of all buildings. District safety plans and procedures are in place to ensure students' safety as well as to prepare for emergencies. We conduct regularly scheduled fire and disaster drills, and each classroom is equipped with a backpack containing emergency supplies. All Sage Canyon staff is trained on federal guidelines and best practices for responding to armed intruder situations on a K-12 school campus. This training has been endorsed by local law-enforcement and empowers staff to implement an options-based response for active shooter and other armed-assailant situations.

Our school complies with district safety and security procedures. Our campus is enclosed by fences and gates remained closed and locked during school hours. Our adult crossing guard helps students cross the street safely on their way to and from school. The staff at Sage Canyon considers the health and safety of our students a top priority. The school custodian makes a visual inspection of the campus every morning before students arrive. Staff members supervise students at each recess and lunch periods. All visitors to the campus must check-in at the school office, enter their identification into the visitor management system and wear a visitor badge while on campus. All school district personnel, including district office staff, wear picture identification badges for security purposes. Sage Canyon houses a shed full of safety supplies to use in the event of an emergency. These supplies and materials are inventoried and include water, blankets, first aid materials, bandages, cots, portable toilets, flashlights, and food bars to feed 1,000 people.
